Media Advisory: Alachua County Sheriff Clovis Watson, Jr. and Gainesville Police Chief Lonnie Scott establish an agreement to ensure K-9 service in support of Community Safety

On March 8th, 2023, Alachua County Sheriff Clovis Watson, Jr., Gainesville Police Department Chief Lonnie Scott, Gainesville City Manager Cynthia W. Curry and members of Sheriff Watson's Command Staff, met with one another in a joint effort to address public safety as it pertains to the use of law enforcement K-9's within the City of Gainesville.

During their meeting, Sheriff Watson was notified by Chief Scott and City Manager Curry that the Gainesville Police Department will continue operation of their law enforcement K-9 program in a "limited capacity" and with newly established guidelines that will require the approval of the Gainesville Police Department Chief of Police prior to the deployment of a GPD K-9. Based upon the current staffing levels of the Gainesville Police Department K-9 Unit, a formal request was made by Chief Scott and City Manager Curry to Sheriff Watson, asking that the Alachua County Sheriff's Office assist with providing an ASO K-9 in the event that a GPD K-9 is unavailable. An additional request was made that Sheriff Watson make his Special Operations Staff, specifically the K-9 Unit, available to the Gainesville Police Department for specialized training of their K-9 handlers as well as the K-9 itself.

Alachua County Sheriff Clovis Watson, Jr. and Gainesville Police Department Chief Lonnie Scott are pleased to announce that they have come to an agreement in partnership and support of their common interest for the safety of the community, as well as the safety of the law enforcement professionals that they serve.
